# ARCHAEOLOGICAL MONITORING OF THE HEALING ROCK PILINGS INSTALLATION

### INTRODUCTION

On March 17, 1998, three piling holes were augered near the Low Line Bridge for the installation of support pilings for the Healing Rock. These holes were situated five (5) metres east of the east side of the bridge and four (4) metres north of the north bank of the Assiniboine River. Due to the high potential of this location at The Forks, it was deemed necessary to monitor the excavations. The archaeological monitoring was conducted under the terms of Heritage Permit A76-97 (copy attached), issued by Historic Resources Branch, Manitoba Culture, Heritage and Citizenship.

The auger holes were twelve (12) inches in diameter and extended to a depth of 15 feet (4.6 metres). The spacing was in a triangular pattern with the apex to the north and a distance of approximately one metre between each hole.

#### **OBSERVATIONS**

The soil profiles observed in the auger cuttings indicated considerable prior disturbance at the location. The upper stratum consisted of railroad cinder deposits extending to a depth of 165 cm. Below this layer, a stratum of blackish brown silty clay, averaging 10 cm thick, was recorded. Rather than this stratum being a buried soil horizon, it has resulted from staining by downward leaching of minuscule coal dust particles from the upper stratum. Underlying the stained layer, the soil is a light brown silty clay which contains small amounts of pea gravel, fragments of brick, and cinders. It is apparent that this soil had been excavated during the construction of the north abutment of the Low Line Bridge and re-deposited after construction. Undisturbed riverine silty clay, of the same light brown colour, was encountered at a depth of 400 cm in the two holes closest to the abutment and at a depth of 365 cm in the easternmost hole. No evidence of relict soil horizons or Pre-Contact archaeological horizons was observed in the undisturbed sediments.

#### RECOMMENDATIONS

No further archaeological activity is required in conjunction with this project. The scope of the prior disturbance due to bridge abutment construction is unknown, but would extend further to the east and north.

- a. All surface collections, excavations, etc. are to be carried out using the provenience system established for use at The Forks;
- b. All heritage objects (artifacts) recovered are to be catalogued according to the CHIN system with the relevant Borden designations; D1Lg-32/96B; D1Lg-33/96B; or as appropriate;
- c. All heritage objects from The Forks are to be deposited with the Manitoba Museum by July 1, 1998, for permanent curation and storage, unless appropriate loan requirements are arranged with the Curatory of Archaeology prior to that date;
- d. A complete set of archaeological field records, catalogue sheets, laboratory analysis records, photographs, reports, etc. are to be deposited with the Manitoba Museum of Man and Nature upon completion of the archaeological research, or sooner if required; and any subsequent revisions or additions to these records are to be filed as soon as possible thereafter;
